



JDC Entwine 2025 KAHAL Microgrant Agreement

The following agreement confirms the terms and conditions for receiving a KAHAL Abroad Experience Microgrant (“Microgrant”).

Please acknowledge receipt and acceptance of the terms and conditions by signing and dating this letter and returning a signed copy to JDC.

- 1. Reimbursable Expenses.** Subject to all other terms of this Agreement, and if your application is approved, you will receive a Microgrant, in the form of a reimbursement, of up to \$150 in total per semester, for amounts spent on Jewish experiences in your study abroad location (“Reimbursable Expenses”). Reimbursable Expenses can include, for example, paying for an entrance ticket to attend a Jewish event, providing supplies to celebrate Shabbat or a Jewish Holiday in a student space, or running a one-off event to bring Jewish students together in their abroad destination.
- 2. Requirements for Reimbursement Distribution.** To receive reimbursement funds for approved Reimbursable Expenses, this Agreement must be signed, and if your application is approved, you must submit detailed receipts accurately reflecting any Reimbursable Expenses to KAHAL staff via the KAHAL Microgrant Preferred Method of Reimbursement Form within 30 days of the purchases. We will request banking information from you so that we can transmit reimbursement funds to you.
- 3. Recognition.** If hosting a local event using Reimbursable Expenses, you must clearly state in any written materials or social media posts for their event, that the event is “made possible in part through KAHAL.” Please tag @jdcentwine on any Instagram posts.
- 4. Additional Warranties.** You will remain in compliance with all terms and conditions of this Agreement throughout the term and warrant that:
 - A. You will not use Reimbursable Expenses to host any events where alcohol is served to anyone under the legal drinking age.
 - B. You will comply with all applicable laws and regulations, including those related to COVID-19 restrictions on in-person activities, while, in any way, making use of or reference to Reimbursable Expenses.
 - C. You will not use Reimbursable Expenses in any way for political purposes, to carry out propaganda, or otherwise attempt to influence legislation, to influence the outcome of any specific public election, or to make any grant which does not comply with this Agreement.
 - D. No one employed by or rendering services to you in connection with the Reimbursable Expenses will receive any tangible benefit or privilege, including, without limitation, any fee, commission, or other compensation of any kind (other than salaries or reasonable compensation for services) from either you or JDC in return for this Microgrant.
- 5. Media License.**



- A. JDC grants you a limited, nonexclusive license to use the KAHAL logo solely in connection with programming and events where Reimbursable Expenses are used, and subject to the terms of this Agreement. You may make, in consultation with JDC, only necessary reproductions, adaptations, translations, or modifications to the JDC Entwine logo. However, you may not, under any circumstances, make such alterations in any way that compromises the integrity of JDC or the KAHAL logo.
 - B. You grant to JDC a limited, nonexclusive license to use any materials created in connection with programming and events where Reimbursable Expenses are used, including but not limited to promotional materials, photographs, voice and video recordings in connection with JDC's work. You will provide all such materials to JDC Entwine within 10 days of hosting an event.
 - C. You agree to consult with JDC prior to publishing any material/articles related to your use of any Reimbursable Expenses and to allow JDC the opportunity to read and copyedit pieces prior to publication in order to protect material that may be sensitive to the people whom we serve.
- 6. Taxes.** You agree to bear the full responsibility for meeting any taxation obligations connected to receipt of the Microgrant.
- 7. Additional Terms.**
- A. **Relationship.** The nature of this Agreement is to offer an opportunity to provide funding. No employment, partnership, joint venture or agency relationship is created, implied or deemed to be created pursuant to this Agreement. You understand that this Agreement does not provide a guarantee that you will receive a Microgrant, and you understand that to the extent you receive a Microgrant under this Agreement, JDC is not obligated to provide you or any of your affiliates any additional financial support, or other support, in connection with the Microgrant, the Agreement or for any other reason.
 - B. **Indemnification.** You agree to indemnify and hold harmless JDC from any claims, losses, and liabilities relating in any way to the reimbursement or programming and events where Reimbursable Expenses are used.
 - C. **Prohibited Activity.** JDC will not provide you a Microgrant, and will not consider you for a future Microgrant, in the event that you: (1) submit to JDC false, fraudulent, or intentionally misleading receipts or other information relating to Reimbursable Expenses; (2) breach any material term, condition, or procedure of this Agreement; or (3) in any way injure, tarnish, damage, or otherwise negatively affect the reputation and goodwill associated with JDC.
- 8. Privacy Policy and Data Processing.** You agree and understand that JDC will collect, process, and transfer your personal data in accordance with the [JDC Entwine KAHAL Microgrant Notice and Policy for the Collection and Use of Personal Information](#) ("Privacy Policy"), and that by signing this Agreement you agree to the terms of the Privacy Policy. You understand that JDC may transfer your



personal data to third parties including Donors and/or partnering agencies in accordance with the Privacy Policy.

JDC wants to process your personal data, including basic personal information, demographic information, and religious affiliation data for the purpose of organizing the JDC Entwine KAHAL Microgrant program.
